**ORDER**

At its September 2022 Session, the Judicial Conference of the United States approved an increase to the maximum page per original and copy transcript fee rates for fiscal year 2025, effective October 1, 2024.

The Schedule of Maximum Transcript Rates for all categories of transcripts for fiscal year 2025 is as follows:

<b>MAXIMUM TRANSCRIPT RATES - ALL PARTIES PER PAGE</b>			
	<b>Original</b>	<b>First Copy to Each Party</b>	<b>Each Add'l Copy to the Same Party</b>
<b>30-Day Transcript (Ordinary)</b> A transcript to be delivered within thirty (30) calendar days after receipt of an order.	\$4.40	\$1.10	\$0.75
<b>14-Day Transcript</b> A transcript to be delivered within fourteen (14) calendar days after receipt of an order.	\$5.10	\$1.10	\$0.75
<b>7-Day Transcript (Expedited)</b> A transcript to be delivered within seven (7) calendar days after receipt of an order.	\$5.85	\$1.10	\$0.75
<b>3-Day Transcript</b> A transcript to be delivered within three (3) calendar days after receipt of an order.	\$6.55	\$1.30	\$0.90
<b>Next-Day Transcript (Daily)</b> A transcript to be delivered on the calendar day following receipt of the order (regardless of whether that calendar day is a weekend or holiday) before the normal operating hour of the clerk's office.	\$7.30	\$1.45	\$1.10
<b>2-Hour Transcript (Hourly)</b> A transcript of proceedings to be delivered within two (2) hours from receipt of the order.	\$8.70	\$1.45	\$1.10

<p><b>Realtime Translation</b>            A draft unedited transcript produced by a certified realtime reporter as a byproduct of realtime to be delivered electronically during proceedings or immediately following receipt of the order.</p> <p>Orders placed on or before the day of the proceeding will be batched together for purposes of determining the number of fees; and subsequent orders will be charged at the lowest page rate assessed on the previous orders.</p>	One feed <sup>1</sup> , \$3.70 per page; two-to-four feeds, \$2.55 per page; five or more feeds, \$1.80 per page.	n/a	n/a
